



## CRITICAL INFORMATION SUMMARY

### GROUP 70 PLAN (IRIDIUM NETWORK)

#### Information about the Service

The service provided is a Pivotel Satellite mobile satellite service which uses the Iridium low earth orbit satellite network together with Iridium manufactured customer equipment. Customers can use the service to make and receive domestic and international voice calls, to send and receive messages including text messages (SMS) and emails, and to access data services including browsing the Internet.

Minimum Term:	The minimum term is 24 months.
Included Call Value:	Up to \$40.00 for Standard National calls, Standard National Mobile calls and Standard SMS. The Included Call Value excludes Premium Calls, calls to Special Numbers, International Direct Dial (IDD) calls and Premium SMS.

#### Information about Pricing

Minimum Monthly Charge:	\$70.00 per month. At least 3 services must be connected on this plan.
Early Termination Charge:	The maximum charge for early termination is \$1,680.00 plus any excess call charges per service.
Cost of a 2 Min Call:	\$2.40 before any discounts to Standard National numbers and Standard National Mobile numbers.
Cost of a Standard SMS:	\$0.50 each before any discounts to Standard National Mobile numbers.
Cost of 1MB of Data:	Not applicable.
Number of Standard Calls:	If you restricted your use solely to Standard National Mobile Calls each of 2 minutes in duration, you could make 16 calls.
Non-Standard Call Prices:	The price for non-Standard Calls including international direct dial, Value Added Services, Special Calls, and Roaming can be varied by Pivotel Satellite at any time in its sole discretion.
Cellular Calls:	It is possible to use the SIM supplied by Pivotel Satellite in a standard 3G/GSM handset to make and receive cellular calls, messaging and data. The cellular service is provided using the Vodafone Wholesale 3G network. Refer to the detailed plan information for cellular call pricing, and the detailed terms and conditions for cellular use.
