Prices quoted are in AUD including GST and are subject to change. 3 month minimum terms apply for Thuraya IP AU monthly plans and 12 month minimum terms apply for Thuraya IP AU annual plans. Please refer to the above table for minimum cost over minimum term for the plan. For Monthly plans, the provision of the service will continue after conclusion of the minimum term of the contract unless you request, in writing, cancellation of the service. For Annual plans, the service will automatically be renewed with a new 12-month minimum contract term at the end of the current minimum term unless you request, in writing, cancellation of the service. Plans can be upgraded at any time but will only take effect on the next billing cycle and the minimum term will be reset. Any unused data will not carry forward to the new plan. A plan downgrade is allowed after the minimum term for Thuraya IP AU monthly plans. Downgrades within the minimum term will have an early termination fee apply equivalent to the monthly access fee from the downgrade date to the minimum contract expiry date. A plan downgrade is allowed at any time for Thuraya IP AU annual plans however any unused data will not be carried forward to the new plan. A new minimum term will begin after a plan downgrade. A compatible Thuraya IP device is required to access the Pivotel Thuraya IP AU service (see device pricing). You will receive a bill by email from Pivotel listing any payments you have made during the billing period and a summary of your service usage to enable you to keep track of your overall service usage and monthly spend. You may receive a pro-rata access fee charge on your first Pivotel bill, calculated from the actual date of service connection to the date of your first bill. Itemized billed and unbilled service usage is available in the secure Selfcare website at www.pivotel.com.au/selfcare. An itemised bill listing all of your service usage events is available on request. Pivotel plans are available to credit approved customers only.
